## AN ORDINANCE AMENDING SECTION 1-2-15 OF THE VILLAGE CODE (Ordinances Adding Paragraph (e) Enforcement Officer)

NOW, THEREFORE, it is hereby ordained by the Village President and the Board of Trustees of the Village of Mt. Auburn, as follows:

**SECTION 1:** Section 1-2-15 of the Village Code is hereby amended and shall now read as follows:

\* \* \*

- (F) Enforcement Officer: The Board is authorized to hire an enforcement officer for the Village of Mt. Auburn. This person shall report directly to the Ordinance Committee.
  - (1) Qualifications:
    - (a) Must be at least 18 years of age
    - (b) live within the Village of Mt. Auburn
    - (c) No felony convictions
  - (2) Duties:
    - (a) Issuing citations as directed by the Ordinance Committee relative to any ordinance violation;
    - (b) Assume all duties relative of the current dog catcher position;
    - Provide a written report each month to the Ordinance Committee Chairperson at least 3 days prior to the Monthly Board Meeting;
    - (d) Attend all ordinance meetings and monthly board meetings unless otherwise approved or directed by the Ordinance Committee Chairperson;
    - (e) And such other duties as assigned by the Ordinance Committee.

## **SECTION 2:** EFFECT DATE

This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law. Nothing in this section prevents the enforcement officer from issuing citations arising out of violations prior to the enactment of this code.
