An individual user fireworks display permit application can be made by any owner and resident of real property in the Village of Mt. Auburn for intended discharge on such applicant's property.

Such application is made pursuant to Illinois Compiled Statutes 425 ILCS 35 and shall be subject to all requirements contained within said Statute.

Fee - \$25.00. Acceptable forms of payment include cash and check (made payable to the Village of Mt. Auburn).

All permit applications must be filed between May 1 and June 30.

Such use is restricted to the following dates: July 3, 4, and 5 each year, subject to the following: If the 4th of July falls on a Monday or Tuesday, the Saturday before will be allowed. If the 4th of July falls on Wednesday or Thursday, the Saturday after will be allowed.

A separate application must be completed for <u>each</u> day requested.

The application must specify the name and address of the requested permit holder, the general type and approximate quantity of fireworks, and the date and location of the proposed use.

In the interest of neighboring property owners, the applicant must further provide to the Village proof of Homeowner's Liability Insurance covering the applicant in the case of personal injury or property damage that occurs as a result of the discharge of the fireworks.
