## VILLAGE OF MT. AUBURN REGULAR MEETING May 1, 2018

The Village Board of Mt. Auburn met in regular session with Mayor Brent Milburn presiding. The meeting was called to order with the Pledge of Allegiance.

Present were: Mayor Brent Milburn, Board Members: Charlene Saulsberry, Glen Goodrich, Denise Carey, Sandra Gooder, Mike Krachum, and Dixie Vincent. Treasurer Gerry Mahr and Clerk Sheri Clayton were also present.

## Public Speaks:

Amanda Rankins asked about the status on getting together to talk about the electrical issues at the park. Brent informed her that it would be discussed later in the meeting.

Brent recognized Andrew Whitehead, Fire Chief of MTAFPD. Andrew asked the board to look over the fines that will be associated with the Fire Protection District being called out to an illegal burn. Fines for the Fire Protection District will be \$35/person who attends the call and \$125/fire truck taken to the call. There will also be an additional \$50 fee for the Village. Andrew agreed to the new ordinance.

Brent recognized Churck Carey, Carey Disposal owner. Chuck stated that he talked to Pugsley regarding a recycling bin. Chuck is working on putting a bid together to have the recycling bid hauled away and dumped. They are currently waiting for more bids from other companies. Info given from Carey's is on file.

Dennis Atteberry stated that if a fine is given and goes unpaid the \$50 portion of the fine will jump to \$250 plus court and attorney fees. This amount will be on top of the amount that is due to the FPD.

Atteberry went over some changes that were made to ordinance 175. Section 5-1 will state that the hours for the disposal site will be by appointment only. When hours are set they will be posted at the Village Hall. Section 2-E will state that residents may burn yard refuse in ditch

adjacent to their property. Section 4b-4 will state the neighbor may help burn another residents leaves on helping neighbors property.

Mike Krachum stated that regarding Ordinance 174, 6-1-6, he didn't think they board was going to make it so that 50 residents had to want another hauler for one to be able to get the license. He stated the consumer should be able to decide who they want to use and shouldn't have to be restricted to who they have to use.

Atteberry went over subjected changes regarding the number of households. Sections to be changed were 6-1-6 B, E, G.

Atteberry also went over ordinance 176. He discussed this dissolving the health department and health officer. The health committee will have all responsibilities of those being dissolved.

## Committee Reports:

Finance – Gerry discussed direct deposit information. Said it can take up to two federal business days for deposit to transfer.

Health – Sandy went over dog catcher report. Report on file.

Parks – Mike gave Denise Carey a copy of the blueprint of what electrical work needs done at the park. He stated they are about ready to get together with picnic association, park committee, and Matt Chamberlain. Brent mentioned that a \$250 grant was awarded by Walmart to help with the work. Gerry stated the check has already been deposited into the bank.

Police – Monthly report on file. New ATV stickers are available.

Sidewalks – Nothing to report.

Streets & Alleys – Glen asked Sky if a date had been set for Louise Marsh to do the roads. Sky stated that he had not set a date in stone yet.

Water – Sky talked to engineer on 5/1/18. The engineer stated that the chemical they were looking into isn't designed to be pressurized. They are going to look at what we already have and use to see if any changes can be made using those chemicals. Sky said it is a work in progress. He also stated that he had received an email from Darin Clarke from Suez stating that Darin was no longer with the company. Sky also asked the board if they had a chance to look over Hydrostop info. Brent will put on agenda for next meeting.
