ORDINANCE NO. 101

AN ORDINANCE MAKING APPROPRIATIONS FOR ALL CORPORATE PURPOSES FOR THE VILLAGE OF MT. AUBURN, FOR THE FISCAL YEAR COMMENCING ON THE FIRST DAY OF MAY A.D. 2005 AND ENDING ON THE THIRTYTH DAY OF APRIL A.D. 2006

Be ordained by the President and the Board of Trustees of the Village of Mt. Auburn, Illinois.

Section I.
