**AN ORDINANCE AMENDING SECTION 1-2-3 OF THE VILLAGE CODE**  
(Re: Changing dates and times of regular meetings of Board of Trustees)

NOW, THEREFORE, it is hereby ordained by the Village President and the Board of Trustees of the Village of Mt. Auburn, as follows:

**SECTION 1:** Section 1-2-3 of the Village Code is hereby amended and shall now read as follows:


**1-2-3 REGULAR AND ADJOURNED MEETINGS.** Commencing with the month of June 2005, the Regular Meetings of the Village Board of Trustees shall be held in the Village Hall Building on the first Monday of each month and shall commence at seven o'clock (7:00) p.m. When said Regular Meeting date falls upon a legal holiday, then such Regular Meeting shall be held at the same hour and place on the first week day (excluding Saturday and Sunday) following such legal holiday. Adjourned Meetings may be held at such times as may be determined from time to time by the Village Board of Trustees.

**SECTION 2.** That the provisions of other Village Code sections, Village of Mt. Auburn Ordinances, Resolutions or Motions heretofore adopted, to the extent they duplicate, conflict herewith, relate hereto, or otherwise affect the validity hereof, shall be disregarded and the terms of this Ordinance shall prevail.


**SECTION 3:** That if any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
