AN ORDINANCE AMENDING SECTION 8. OF VILLAGE OF MT. AUBURN ORDINANCE NO. 5 (Re: Water Rates)

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS, AS FOLLOWS:

Section 1: Section 8. of Village of Mt. Auburn Ordinance No. 5 is hereby amended and shall now read as follows:

Section 8. Rate Schedule.

Commencing May 1, 2007, the following shall be the monthly rates for water supplied by the Village:

Step I – First 2000 gallons or less:

\$12.00 (minimum charge)

Step II – Next 2001 gallons to 20,000 gallons:

\$6.35 per 1000 gallons or part thereof

Step III – Next gallons above 20,000 gallons:

\$5.70 per 1000 gallons or part thereof

Commencing May 1, 2008, and on May 1 of each Village Municipal year thereafter, the foregoing monthly rates shall be automatically increased by an amount equal to three percent (3%) over the monthly rates for the immediate preceding Village municipal year (i.e. May 1 to April 30).

All users shall be billed for water usage on a monthly basis.

Section 2: That if any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

Section 3: That the provisions of other Village of Mt. Auburn Ordinances, to the extent they duplicate, conflict with or otherwise affect the validity hereof, shall be disregarded.

Section 4. This Ordinance shall be effective upon its passage, approval and publication in pamphlet form as provided by law.
