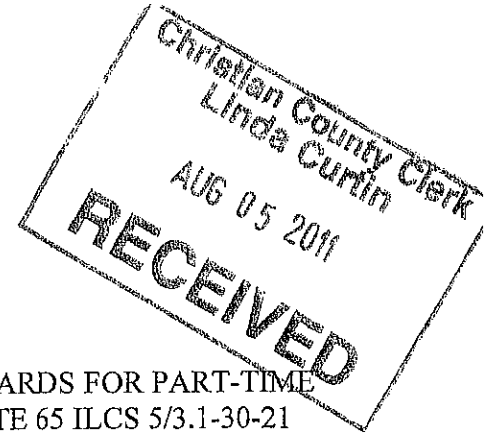

AN ORDINANCE SETTING FORTH THE HIRING STANDARDS FOR PART-TIME POLICE OFFICERS IN COMPLIANCE WITH ILLINOIS STATUTE 65 ILCS 5/3.1-30-21

The VILLAGE OF MT. AUBURN, Illinois, pursuant to Illinois Compiled Statutes Chapter 65, Section 5/3.1-30-21 ordains to adopt hiring standards for part-time police officers.

BE IT ORDAINED by the President and the Village Board of Trustees of the Village of Mt. Auburn, Christian County, Illinois, as follows:

WHEREAS, the State of Illinois has enacted a revision to the Illinois Municipal Code requiring that municipalities employing part-time police officers shall, by ordinance, establish hiring standards for part-time police officers and shall submit those standards to the Illinois Enforcement Training Standards Board; and

WHEREAS, the Village Board of Trustees of the Village of Mt. Auburn, Christian County, Illinois, wish to maintain compliance with the Illinois statutory mandate as aforesaid;

NOW, THEREFORE, BE IT ORDERED by the President and Village Board of Trustees of the Village of Mt. Auburn, Christian County, Illinois, as follows:

1. That all police officers, other than those officers who shall be employed on a full-time basis, shall be qualified to enter and successfully complete any training mandated by the Illinois Law Enforcement Training Standards Board;
2. That the aforesaid hiring standard, particularly with respect to part-time police officers employed by the Village of Mt. Auburn, Christian County, Illinois, shall be submitted to the Illinois Law Enforcement Training Standards Board, as required by statute.
3. Officers employed part-time by the Village of Mt. Auburn, Christian County, Illinois, shall carry out duties and responsibilities including: patrolling the village, issuing tickets when necessary, writing incident reports, responding to calls from Village Residents, handling complaints from Village Residents, seeing that bars comply to their hours of operation, delivering Ordinance violation letters or tickets when necessary, attending monthly Board Meetings when possible, maintaining the squad car, and reprimanding individuals within the Village when necessary.
4. Part-time police officers employed by the Village of Mt. Auburn, Christian County, Illinois, have Conservator of the Peace Powers, which includes the ability to arrest or cause to be arrested all persons who break the peace and are found violating any municipal ordinance or any criminal law of the state. For this reason, the officer will be required prior to the time of hiring, or within 6 months of hiring, to have either completed or be enrolled in the Mandatory Basic Law Enforcement Training Course (400 hours); 40 hours of Mandatory Firearms Training; and be certified to operate a stun gun.
