**AN ORDINANCE AMENDING SECTION 7-3-1
OF THE MT. AUBURN VILLAGE CODE
(RE: Hours of operation for sale of Alcohol)**

NOW, THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, CHRISTIAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Section 7-3-1 of the Mt. Auburn Village Code is hereby amended and shall now read as follows:

(a) HOURS. It shall be unlawful to sell or offer for sale at retail any alcoholic liquor in the Village except as follows:

- Monday through Thursday: 8:00A.M. to 12:00P.M. (midnight)
- Friday and Saturday: 8:00A.M. to 1:00A.M.
- Sunday: 12:00 (noon) to 10:00P.M.

(b) It shall be unlawful to keep open for business or to admit the public to any premises in or on which alcoholic liquor is sold at retail except for the hours noted in paragraph (a) above.

(c) Any holder of a retail liquor license or his agent or employee who violates the provisions of this Chapter in regulating the legal hours of operation shall, upon conviction fo the first offense, be fined not less than one hundred dollars (\$100.00), nor more than five hundred dollars (\$500.00) and for the second offense, be fined not more than five hundred dollars (\$500.00) and suffer the revocation of such retail liquor license for a period of seven days.

SECTION 2: EFFECT DATE shall be August 13, 2013.

This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
