ORDINANCE NO. 147

IMPOUND ORDINANCE

NOW, THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, CHRISTIAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Any motorized vehicles including but not limited to automobiles, ATV's Golf Carts, tractors etc. which is seized by any law enforcement agency within the Village of Mt. Auburn, shall be stored at the Impound Lot.

SECTION 2: The impound lot shall be maintained by the Village of Mt. Auburn police department. However, nothing in this Ordinance shall be construed to undertake maintenance of said vehicle or otherwise assumes liability for any damage to said vehicle or any items lost or stolen that may have been in said vehicle.

SECTION 3: Storage fee will be assessed at \$20.00 per day with a minimum storage of \$20.00. Storage is based upon calendar days placed into storage and not based upon the amount of hours in storage. For example, an item placed in storage at 10:00p.m. and is released at 1:00a.m. will constitute 2 days of storage.

SECTION 4: All fees are to be paid in full prior to release of said vehicle. The fees will be paid by cash, certified check or money order.

SECTION 5: If any section, clause provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

SECTION 6: EFFECT DATE

This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

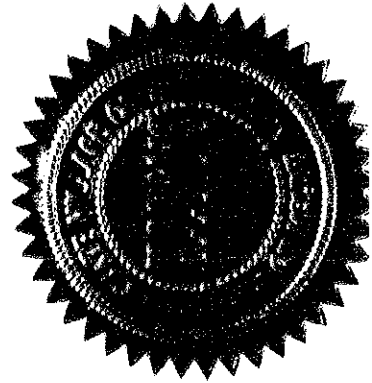

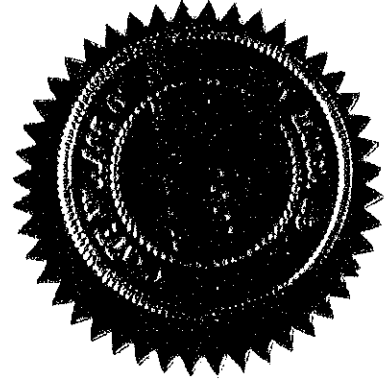
