AN ORDINANCE TO CODIFY THE RESOLUTION PASSED
BY THE VILLAGE BOARD OF TRUSTEES AMENDING
ARTICLE III OF CHAPTER 1 OF MT. AUBURN VILLAGE CODE
(Re: Salaries)

WHEREAS, the Mayor and the Board of Trustees of the Village of Mt. Auburn in the Village of Mt. Auburn, County of Christian, State of Illinois, have passed an ordinance amending the salaries of the Village Mayor, Village Clerk, Village Treasurer, and Village Trustees.

WHEREAS, this Ordinance # 148 shall revise Article III of Chapter 1 which was previously amended with Ordinance #99. This replaces all prior amendments to this Section of the Code.

NOW, THEREFORE, BE IT ORDERED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS AS FOLLOWS:

SECTION 1: That Article III of Chapter 1 of the Mt. Auburn Village Code is hereby amended and shall now read as follows:

CHAPTER 1

ADMINISTRATION

ARTICLE III – SALARIES

A. MAYOR: Commencing with the term of office of the Mayor (i.e. Village President) to be elected in 2013 and to be elected thereafter, the Mayor shall receive as salary the sum of Three Hundred Fifty Dollars (\$350.00) per month.

B. VILLAGE CLERK: Commencing with the term of office of the Village Clerk to be appointed in 2013, and to be appointed each year thereafter in May each year, Village Clerk shall receive as salary the sum of One Hundred Dollars (\$100.00) per month.

C. VILLAGE TREASURER: Commencing with the term of office of the Village Treasurer to be appointed in 2013, and to be appointed each year thereafter in May each year, the Village Treasurer shall receive as salary the sum of Four Hundred Fifty Dollars (\$450.00) per month.

D. VILLAGE TRUSTEES: Commencing with the terms of office of each Village Trustee to be elected in 2013 and for the terms of office of each trustee to be elected thereafter, each of such Trustees shall receive as salary the sum of Eighty Dollars (\$80.00) per month.

E. SPECIAL MEETINGS: Commencing with the terms of office to be elected in 2005 and for terms of office to be elected thereafter, the Mayor, Clerk, Village Treasurer, and Trustees shall receive an additional Twenty Dollars (\$20.00) for each special Village Board of Trustee's meeting they attend.

F. COMMITTEE MEETINGS: Commencing with the terms of office to be elected in 2005 and for the terms of office to be elected thereafter, the Mayor, Clerk, and Trustee shall receive an additional Twenty Dollars (\$20.00) for each Village committee meeting they attend.

Section 2: That if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision, or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

Section 3: That other provisions of the Mt. Auburn Village Code or other Ordinances, to the extent they duplicate, conflict with, or otherwise affect the validity hereof, shall be disregarded.

Section 4: This Ordinance shall be effective immediately upon its passage, approval, and publication in pamphlet form as provided by law.
