## VILLAGE OF MT. AUBURN ORDINANCE NO.

#### AN ORDINANCE TO CODIFY THE RESOLUTION PASSED BY THE VILLAGE BOARD OF TRUSTEES AMENDING ARTICLE III OF CHAPTER 1 OF THE MT. AUBURN VILLAGE CODE (Re: Salaries)

WHEREAS, the Mayor and the Board of Trustees of the Village of Mt. Auburn in the Village of Mt. Auburn, County of Christian, State of Illinois, have passed an ordinance amending the salaries of the Village Mayor, Village Clerk, Village Treasurer, and Village Trustees.

WHEREAS, this Ordinance #\_164 shall revise Ordinance #148.

NOW, THEREFORE, BE IT ORDERED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS AS FOLLOWS:

**SECTION 1:** That Article III of Chapter 1 of the Mt. Auburn Village Code is hereby amended and shall now read as follows:

#### CHAPTER 1

#### **ADMINISTRATION**

#### ARTICLE III – SALARIES

- A. MAYOR: Commencing May 1, 2016, the Mayor (i.e. Village President) shall receive as salary the sum of Four Hundred Fifty Dollars (\$450.00) per month.
- B. <u>VILLAGE CLERK:</u> Commencing May 1, 2016, the Village Clerk (which is an appointed position) shall receive as salary the sum of Two Hundred and Fifty Dollars (\$250.00) per month.
- C. <u>VILLAGE TREASURER:</u> Commencing May 1, 2016 the Village Treasurer shall receive as salary the sum of Four Hundred Dollars (\$400.00) per month.
- D. <u>VILLAGE TRUSTEES:</u> Commencing with the terms of office of each Village Trustee to be elected in 2016 and for the terms of office of each trustee to be elected thereafter, each of such Trustees shall receive as salary the sum of Eighty Dollars (\$80.00) per month.
- E. <u>SPECIAL MEETINGS</u>: Commencing with the terms of office to be elected in 2005 and for terms of office to be elected thereafter, the Mayor, Clerk, Village Treasurer, and Trustees shall receive an additional Twenty Dollars (\$20.00) for each special Village Board of Trustee's meeting they attend.

- F. <u>COMMITTEE MEETINGS</u>: Commencing with the terms of office to be elected in 2005 and for the terms of office to be elected thereafter, the Mayor, Clerk, and Trustee shall receive an additional Twenty Dollars (\$20.00) for each Village committee meeting they attend.
- **Section 2:** That if any section, clause, provision, or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision, or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.
- **Section 3:** That other provisions of the Mt. Auburn Village Code or other Ordinances, to the extent they duplicate, conflict with, or otherwise affect the validity hereof, shall be disregarded.
- Section 4: This Ordinance shall be effective immediately upon its passage, approval, and publication in pamphlet form as provided by law.
