AN ORDINANCE DISSOLVING THE POSITION OF HEALTH OFFICER AND THE HEALTH DEPARTMENT WITH THE HEALTH COMMITTEE ASSUMING ALL DUTIES AND RESPONSIBILITIES

WHEREAS, Chapter 6, Article I Sections 13 and Sections 14 of the Village Code created a health department and health officer for the Village of Mt. Auburn;

WHEREAS, the Village Board finds that this office and department is duplicative of the duties and responsibilities of the Village Health Committee;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Village Trustees of the Village of Mt. Auburn as follows:

Section 1: Repeal and replace

This ordinance repeals and replaces Chapter 6, Article 1, section 13 and Section 14 by dissolving the health officer and health department. The Health Committee shall assume all obligations and responsibilities associated with the Health officer and Health Department of the Village of Mt. Auburn..

Section 10: Effective Date

This ordinance shall be in full force and effect May 1, 2018.
