## AN ORDINANCE AUTHORIZING THE EXECUTION OF A MEMBERSHIP AGREEMENT WITH JULIE, INC.

WHEREAS, attached hereto and incorporated herein by reference is a copy of a Membership Agreement, to be entered into by and between the Village of Mt. Auburn and Julie, Inc.;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS:

Section 1: That the President and Board of Trustees hereby approve of the Village entering into a Membership Agreement with Julie, Inc. in a form similar to the one attached hereto subject, however, to such substitute or additional terms or provisions as the President may deem appropriate; and by and on behalf of the Village of Mt. Auburn the President and Clerk hereby authorized and directed to sign such Agreement in the final form acceptable to the President and to place the Village's corporate seal thereon.

Section 2: That if any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

Section 3: This Ordinance shall be effective upon its passage, approval and publication in pamphlet form as provided by law.
