AN ORDINANCE AUTHORIZING THE EXECUTION OF

WHEREAS, attached hereto and incorporated herein by reference is a copy of an Intergovernmental Cooperation Contract, to be entered into by and between the Village of Mt. Auburn and Illinois Municipal League Risk Management Association;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS:

Section 1: That the President and Board of Trustees hereby approve of the attached written Contract, and hereby authorize and direct the President to sign said Contract, or any modifications thereto as he may agree to, and duplicate originals thereof, by and on behalf of the Village of Mt. Auburn; and further, the Clerk is hereby directed and authorized to attest to the signing of said Contract and to place the corporate seal of the Village of Mt. Auburn thereon.

Section 2: That the provisions of other Village of Mt.

Auburn Ordinances, to the extent they duplicate, conflict with or otherwise affect the validity hereof, shall be disregarded.

Section 3: That if any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

Section 4: This Ordinance shall be effective upon its passage, approval and publication in pamphlet form as provided by law.
