ORDINANCE NO. 26

AN ORDINANCE AMENDING SECTION 11-2-11 OF ARTICLE II OF
CHAPTER 11 OF THE MT. AUBURN VILLAGE CODE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF MT. AUBURN, ILLINOIS:

Section 1. That Section 11-2-11 of Article II of Chapter 11
to the Mt. Auburn Village Code is hereby amended and shall now
read as follows:

11-2-11 DISCHARGE OF FIREARMS OR BOW AND ARROW. It shall be
unlawful to discharge any firearm, bow and arrow or air gun in
the Village or so that the bullet, arrow, missile or projectile
therefrom enters the Village, provided that this section shall
not be construed to prohibit any officer of the law to discharge
a firearm in the performance of his duty; nor to any citizen to
discharge a firearm when lawfully defending his personal
property.

Section 2. That if any section, clause, provision or
portion of this Ordinance shall be held to be invalid or un-
constitutional by any Court of competent jurisdiction, such
holding shall not affect or otherwise impair any other section,
clause, provision or portion of this Ordinance which is not, in
or of itself, invalid or unconstitutional.

Section 3. This Ordinance shall be effective upon its
passage, approval and publication in pamphlet form as provided by
law.
