ORDINANCE NO. 30

AN ORDINANCE ADDING A NEW ARTICLE IV TO CHAPTER 1,
A NEW PARAGRAPH E TO ARTICLE III OF CHAPTER 1 AND
AMENDING PARAGRAPH D OF ARTICLE III OF CHAPTER 1 AND
AMENDING PARAGRAPH (A) OF SECTION 7-2-5 OF ARTICLE II
OF CHAPTER 7, OF THE VILLAGE CODE OF MT AUBURN, ILLINOIS

BE IT HEREBY ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF
TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS, AS FOLLOWS:

Section 1: A new Article IV is hereby added to Chapter 1 of
the Village Code of Mt. Auburn, Illinois, which Article IV shall
read and provide as follows:

ARTICLE IV - EXPENSES REIMBURSEMENT

A. As and for reimbursement for expenses, the Village
President shall receive the sum of Sixty-Two Dollars (\$62.00)
each month, commencing with the month of November, 1991.

B. As and for reimbursement for expenses, the Village Clerk
shall receive the sum of Sixty-five Dollars (\$65.00) each
month, commencing with the month of November, 1991.

C. As and for reimbursement for expenses, the Village
President, Village Clerk, Village Treasurer, and each Village
Trustee shall receive the sum of Twenty Dollars (\$20.00) each
month, but only if he or she attends on the hereafter
scheduled date, one monthly committee meeting of which he or
she is a member of or is required to attend, which meeting or
meetings shall be regularly scheduled for 7:00 P.M. on the
third Wednesday of each month, commencing with the month of
November, 1991.

Section 2: Paragraph D of Article III of Chapter 1 of the
Village Code of Mt. Auburn, Illinois, is hereby amended to now read
as follows:

D. SPECIAL MEETING: The Village President, Village Clerk,
Village Treasurer, and Trustees shall each receive an
additional Five Dollars (\$5.00) salary for each special
meeting they attend, commencing with the month of November,
1991.

Section 3: A new Paragraph E is hereby added to Article III, of Chapter 1 of the Village Code of Mt. Auburn, Illinois, which Paragraph E shall read and provide as follows:

E. VILLAGE TREASURER: Commencing with the month of November, 1991, the Village Treasurer shall receive as salary the sum of Two Hundred Forty-five Dollars (\$245.00) per month.


Section 4: Paragraph (A) of Section 7-2-5 of Article II of Chapter 7 of the Village Code of Mt. Auburn, Illinois, is hereby amended to now read as follows:

(A). Class "A" licenses which shall authorize the retail sale on the premises specified of alcoholic liquor for consumption on the premises as well as other retail sales of such liquor. The annual fee for such license shall be Three Hundred Dollars (\$300.00).

Section 5: That if any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

Section 6: This Ordinance shall be effective upon its passage, approval and publication in pamphlet form as provided by law.

ON MOTION DULY MADE AND SECONDED and pursuant to roll call vote, this Ordinance was passed, approved and adopted this 2nd day of December, 1991.
