## VILLAGE OF MT. AUBURN ORDINANCE NO. 4

## AN ORDINANCE AMENDING ARTICLE III OF CHAPTER 1 AND RESCINDING ARTICLE IV OF CHAPTER 1 OF THE VILLAGE CODE OF MT. AUBURN

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, ILLINOIS:

Section 1: Commencing with the term of office of the Village President, Village Clerk, and each Trustee to be elected in 1993, Article III of Chapter 1 of the Village Code of Mt. Auburn, Illinois, shall be amended to then read as follows:

- A. Commencing with the term of office of the Village President to be elected in 1993, the Village President shall receive as salary the sum of One Hundred Forty-two Dollars (\$142.00) each month; plus, an additional Five Dollars (\$5.00) salary for each special meeting he or she attends; and as reimbursement for expenses, the further sum of Five Dollars (\$5.00) each month, but only if he or she attends at least one monthly committee meeting each month of which he or she is a member of or is required to attend, which meeting or meetings shall be regularly scheduled for 7:00 P.M. on the third Wednesday of each month.
- B. Commencing with the term of office of the Village Clerk to be elected in 1993, the Village Clerk shall receive as salary the sum of One Hundred Fifty Dollars (\$150.00) each month; plus, an additional Five Dollars (\$5.00) for each special meeting he or she attends.
- C. Commencing with the term of office of each Village Trustee to be elected in 1993, each Village Trustee to be elected in 1993 shall receive the salary of Sixty Dollars (\$60.00) each month; plus, an additional Five Dollars (\$5.00) for each special meeting he or she attends; and as reimbursement for expenses, the further sum of Five Dollars (\$5.00) each month, but only if he or she attends at least one monthly committee meeting each month of which he or she is a member of or is required to attend, which meeting or meetings shall be regularly scheduled for 7:00 P.M. on the third Wednesday of each month.
- D. Commencing with the term of office of each Village Trustee to be elected in 1995, each Village Trustee to be elected in 1995 shall receive the salary of Sixty Dollars (\$60.00) each month; plus, an additional Five Dollars (\$5.00) for each special meeting he or she attends; and as reimbursement for expenses, the

further sum of Five Dollars (\$5.00) each month, but only if he or she attends at least one monthly committee meeting each month of which he or she is a member of or is required to attend, which meeting or meetings shall be regularly scheduled for 7:00 P.M. on the third Wednesday of each month.

- E. Commencing with the term of office of the Village Treasurer to be appointed in 1993, the Village Treasurer shall receive as salary the sum of Two Hundred Forty-five Dollars (\$245.00) each month.
- F. Until above Paragraph D applies, the existing salaries and reimbursement for expenses shall remain the same for each Trustee whose term of office commenced in 1991 as they now are, which are as follows: a salary of Forty Dollars (\$40.00) each month; plus, an additional Five Dollars (\$5.00) salary for each meeting attended; and, as reimbursement for expenses, the further sum of Twenty Dollars (\$20.00) each month, but only if he or she attends at least one monthly committee meeting each month of which he or she is a member of or is required to attend, which meeting or meetings shall be regularly scheduled for 7:00 P.M. on the third Wednesday of each month.

Section 2: Commencing with the term of office of the Village President, Village Clerk and each Village Trustee to be elected in 1993, Article IV of Chapter 1 of the Village Code of Mt. Auburn shall be rescinded.

Section 3: That if any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holding shall not affect or otherwise impair any other section, clause, provision or portion of this Ordinance which is not, in or of itself, invalid or unconstitutional.

Section 4: This Ordinance shall take effect immediately upon its passage and approval as provided by law.
