ARTICLE III - SALARIES

ORDINANCE NO. 8

AN ORDINANCE TO PROVIDE FOR THE SALARIES OF ELECTED OFFICIALS

BE IT ORDAINED BY THE VILLAGE BOARD OF MT. AUBURN, CHRISTIAN COUNTY, ILLINOIS:

That Paragraphs A, B, and C of Article III of the Village Code of Mt. Auburn are deleted in their entirety and the following are provided in their place: (Paragraph D is not deleted).

A. MAYOR: Commencing with the term of office of the Mayor to be elected in 1989, the Mayor shall receive as salary the sum of Sixty Dollars (\$60.00) per month for every regular meeting attended with the exception one regular meeting may be missed per year with pay providing a reasonable excuse be submitted to the Clerk for absence.

B. VILLAGE CLERK: Commencing with the term of office of the Village Clerk to be elected in 1989, the Village Clerk shall receive as salary the sum of Eighty-Five Dollars (\$85.00) per month.

C. VILLAGE TRUSTEES: Commencing with the terms of office of each Village Trustee to be elected in 1989, each of such Trustees to be elected in 1989 shall receive as salary the sum of Forty Dollars (\$40.00) per month for every regular meeting attended with the exception of one meeting may be missed per year with pay providing a reasonable excuse is submitted to the Mayor and Clerk for absence.



ARTICLE 12, SECTIONS 1-7, 1-8, 1-9, 1-10

ORDINANCE NO. 9

AN ORDINANCE TO PROVIDE FOR THE PRESERVATION OF
WATER IN CASE OF EMERGENCY

BE IT ORDAINED BY THE VILLAGE BOARD OF MT. AUBURN, CHRISTIAN
COUNTY, ILLINOIS:

That Article 12, Section 1 of the Code of the Village of Mt.
Auburn is hereby amended to add the following paragraphs thereto:

12-1-7 WATER EMERGENCY. If the village board, in its
judgment, deems that the water supply of the Village is such that
water emergency exists and that the use of water must be
controlled in order to preserve water, the village board for such
emergency situations, may by majority vote declare a water
emergency, which shall grant the Mayor the power to determine
what, if any, restrictions should be applied to restrict water
usage.

12-1-8 MAYOR'S POWER. The Mayor's power in a water
emergency shall include but not be limited to:

A. The power to control the use of water for lawns, gardens,
swimming pools, washing vehicles and any other use that is not
necessary for health and safety purposes.

B. The power to restrict the use of water to certain times
of the day.

12-1-9 NOTIFICATION. If in a water emergency the Mayor
restricts water use, the Mayor shall notify the news media of the
Village as to what these restrictions are and shall have such
restrictions posted in at least the following places:

- A. The Village Hall
- B. the Post Office
- C. The County Courthouse

12-1-10 TERMINATION OF WATER EMERGENCY. If any water
emergency restrictions are instituted by the Mayor as provided
herein, such restrictions shall remain in effect until the Mayor

or the Village Board by a majority vote deems the water emergency no longer exists.


ON MOTION DULY MADE AND SECONDED and pursuant to roll call vote, with 4 Board Members voting YEA, with 0 Board Members voting Nay, and with 2 Board Members either abstaining or being absent, the Mayor announced that the motion had passed and directed that the ordinance be made a permanent part of the record.
