An Ordinance of the Village of Mt. Auburn, Christian County, Illinois. Ascertaining the Prevailing Rate of Wages for Laborers. Workmen and Mechanics Employed on Public Works of said Village

Whereas, the State of Illinois has enacted "An Act Regulating Wages of Labors. Mechanics and Other Workers Employed in any Public Works by the State, County, City or any Public Body or any Political Subdivision or by Anyone Under Contract for Public Works." Approved June 26, 1941, codified as Amended. 820 ILCS 130/1 ct seq. (1998 Bar Edition). Formerly III Rev. Stat. Ch. 48 par. 39s-1 ct seq. and

Whereas, the aforesaid Act requires that the Board of Trustees of the Village of Mt. Auburn investigate an ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Village employed in performing construction of public works, for said Village.

Now, Therefore, be it ordained by the President and Board of Trustees of the village of Mt. Auburn:

Section 1: To the extent and as required by "An Act Regulating Wages of Laborers, Mechanics and Other Worker Employed in any Public Works by State. County, City or any Public Body or any Political Subdivision or by anyone Under Contract for Public Works," approved June 26, 1941 as amended the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the prevailing rate of wages for construction work in Christian County area as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being filed with the Village Clerk at the Village Office and available for public inspection during normal Village Office hours, an incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Village. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

<u>Section 2:</u> Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the aforesaid Act.

<u>Section 3:</u> The Village Clerk shall publicly post or keep available for inspection by any interested party in the main office of the Village this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

Section 4: The Village Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or associations of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

<u>Section 5:</u> The Village Clerk shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

Section 6: The Village Clerk shall cause to be published in the Taylorville Breeze Courier, a newspaper of general circulation within the area, the attached Notice of Prevailing Wages, and such publication shall constitute notice that the determination is effective and this is the determination of the public body.
