PREVAILING WAGE ORDINANCE

WHEREAS, the State of Illinois has enacted "An Act regulated wages of laborers, mechanics and other workers employed in any public works by the State, country, city or any public body or any political subdivisions or by anyone under contract for public works," approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes; and

WHEREAS, the aforesaid Act requires that BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, investigate and ascertain the prevailing rate of wages as defined in said act for laborers, mechanics and other workers in the locality of said BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN employed in performing construction of public works, for said BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN; and

NOW THEREFORE, BE IT ORDAINED THE PRESIDENT OF THE BOARD OF TRUSTEES OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN, as follows:

SECTION 1: To the extent and as required by "An Act regulating wages or laborers, mechanics and other workers employed in any public works by the State, country, city or any public body or any political subdivision or by anyone under contract for public works, "approved June 26, 1941, as amended, the general prevailing rate of wages in his locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Christian County area as determined by the Department of Labor of the State of Illinois as of May 14, 2019 a copy of that determination being attached hereto as Exhibit "A" and incorporated herein by reference. The figures listed herein are updated as of 4/5/2021 based upon what is filed with the Christian County Clerk in Christian County Illinois. The definition of any terms appearing in this Ordinance which area also used in the aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN to the extent required by the aforesaid Act.

SECTION 3: The BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN Clerk shall publicly post or keep available for inspection by any interested party in the main office of the BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or associate of employees who have filed, or file their names and addresses, requesting copies of any determinization stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN Clerk shall promptly file a certified copy of this Ordinance with the Department of Labor of the State of Illinois.

SECTION 6: The BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN Clerk shall cause to be published in a newspaper of general circulation within the area that the determination of prevailing wages had been made. Said notice shall conform substantially to the notice attached hereto. Such publication shall constitute notice that this is the determination of the BOARD OF TRUSTEES OF THE VILLAGE OF MT. AUBURN and is effective.
