An Ordinance of the Village of Mt. Auburn. Christian County, Illinois
Ascertaining the Prevailing Rate of Wages for Laborers, Workmen and
Mechanics Employed on Public Works of Said Village.

This 7th day of May, 2019.

Section 3: The Village Clerk shall publicly post or keep available for inspection by any interested party in the main office of the Village this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

Section 4: The Village Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or associations of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

Section 5: The Village Clerk shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

Section 6: The Village Clerk shall cause to be published in the Taylorville Breeze Courier, a newspaper of general circulation within the area, the attached Notice of Prevailing Wages, and such publication shall constitute notice that the determination is effective and this is the determination of the public body.

Approved June 26, 1941, as amended being 820 ILCS 130/1 et seq.
