Lee Beckman with Milano & Grunloh was present to do the Public Hearing concerning the Community Development Block Grant Program (CDBG) - Water Project, Phase 1 - Exit Conference. The mechanics of the substantially completed Public Facilities project are as follows:

The Village used CDBG grant funds to serve the residents of the Village of Mt Auburn. The target area in the village has a high concentration of low-to-moderate income families and there was a health and safety threat to these target area residents of the Village because of unsafe water distribution system. The CDBG grant was funded by the Federal Government and administered by the State of Illinois. The Village of Mt Auburn was awarded a \$500,000 grant from the CDBG fund. To date, the Village approved over \$67,376.43 match funds toward this project. To date, the Public Facilities improvements is substantially complete and project costs totaled over \$567,376.43.

Lee then opened the meeting for questions, comments and concerns. There were no further questions regarding the current project. If any questions arise, Lee is willing to answer those.

Lee also stated that he is hoping to hear about Phase 2 grant in December or early January.
