ABANDONED SIDEWALK ORDINANCE: NORTH TEMPLE STREET

(West Temple St. between South Chestnut and South Elm Street)

PREAMBLE

WHEREAS, the Village has previously enacted a sidewalk Code formerly cited as Chapter 13, Article IV *et seq.*; and

WHEREAS, said code was amended *instanter* in ordinance no. _____ to allow for the abandonment of a sidewalk; and

WHEREAS, it is requested by the public and is in the best interest of the public that the section of sidewalk on the South side of Temple between South Chestnut and South Elm Street be abandoned;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF THE VILLAGE OF MT. AUBURN, AS FOLLOWS:

1. The sidewalk on the South side of Temple between S. Chestnut Street and S. Elm Street is abandoned by the Village. No further upkeep will be provided for said sidewalk.
2. The sidewalk will be removed at the expense of Shawn and Melissa Carey.

EFFECTIVE DATE: This Ordinance shall be in effect upon its passage, approval and publication as provided by law.
