The Village Board of Mt. Auburn met in regular session with Mayor Amber Dooley presiding. The meeting was called to order with the Pledge of Allegiance.

## **Public Speaks**

Mike inquired about the ordinance violation discussion from the November board meeting. He stated that he has been on "the list" for years and had never been told what for or anything about his violation. He is concerned that others who get violations will not be told what their violation is. He is also doesn't feel it is right having someone deliver violations who, he feels, has ordinance violations themselves. Amber explained the process of an ordinance violation issuance. The process will be as follows; a complaint form will be filled out and then given to the ordinance committee, the committee will then meet to discuss the violation and investigate the complaint, if the committee sees fit a violation will be issued at this time. Mike also expressed concern about residents not being able to afford fines, if they are issued. He suggested trying to help residents correct violations before fines are issued. The board was in agreement that this is a good idea but also expressed concern with the idea. The board also agreed and expressed that they aren't concerned with fines and money being collected, they just want the town cleaned up and ordinances followed.

Stanley Ryan, owner of Village Fast Stop, handed out a letter to residents regarding the closer of the gas station. He is hopeful that someone will buy the station and expressed thanks to those who have patronized VFS.

## **Committee Reports**

Insurance - Need to remove the police car from insurance policy.

Ordinances - Denise contacted the county regarding underage drivers on atv's. They advised that residents are welcome to call the county sheriff's department if there is an issue but they may not have the ability to send someone over right away. Taking pictures of those drives was questioned. Attorney Atteberry stated that photos and verbal concerns are hearsay and it is more difficult to enforce without law enforcement enforcing. He also stated that some ordinances in general will be harder to enforce than others.

Amber stated that Tony Tyler approached her about running an electric fence around his garden. Atteberry stated he would need a 'No Trespassing' sign and a sign warning of the electric fence. Gerry asked if Waste Management has reached out to the Village, as they recently bought Advanced Disposal, about being the waste hauler. Amber has not heard from them. Since a new contract should be done with Waste Management, the board would like to see what they can do for the Village.

Parks - Charlene asked when the wood chips would be spread at the park. Scott is going to find out. Amber also mentioned there would be no Christmas in the park this year.

Police - Charlene informed all that the police car had been purchased by Morrisonville. She would still like to get into the Police Dept office to inventory items and see what else needs organized or sold. Sidewalks - Nothing to report.

Streets & Alleys - Nothing to report.

Water - Rick stated there had been a break a couple of weeks ago, it has since been fixed. Denise mentioned her water bill was high but can not locate a leak. Sky will re-read meter.
